

CONDITIONS OF ENTRY & EXPLANATION OF RIDE

1. The ride is going to be approximately 1.5 to 2 hours (7 Miles), covering roads, tracks and private land . There will be stewards spread along the route . Riders can retire at any point along the route but must inform the nearest steward.
2. Rosettes will be awarded to all riders who take part and large special rosettes will be awarded to those who raise over £50 in sponsorship. **There will be a trophy and prize (donated by Willow Farm) for the rider who raises the most sponsorship**
3. Riding hats to BHS standards and correct footwear must be worn **at all times** by **all riders**.
4. The route will be clearly signed and stewarded. Riders must stay on the permitted route **at all times**.
5. Riders may only ride the course once. NO SUBSTITUTION OF RIDER ALLOWED. Entries will not be accepted without each riders own address.
6. All horses/ponies must be 4 years old or over. No stallions.
7. All entries must be accompanied by the correct entry fee and are received on the condition that the event organisers accept no responsibility for any loss, damage or accident that may be sustained to vehicle, horse or persons or any property whatsoever whilst on the premises. No claims can be entertained for anything that may happen to riders, horses or onlookers in connection with or arising from this Ride.
Failure to carry out instruction from a Steward may lead to disqualification. The Organisers reserve right to refuse an entry, without giving their reasons, and the decisions of the Organisers on any matter will be final.

Declaration & Sponsorship

8. **All riders need to declare at the event by 10.30am** - the declaration point is the café at Willow Farm. Starting times will be issued at declaration. Riders will be set out in small groups, staggered 10 minutes apart. The first group will depart Willow Farm at 11.00am. Brunch will be served in the café after the ride - details included in advert on back page.

9. Riders must find there own sponsors and must guarantee as a condition of entry to settle the amount shown on the form. All sponsorship should be settled by 30th April 2009. Please bring sponsorship form on the day and hand in when you declare. Sponsor forms will be returned to all riders when they report back to the café after completing the route.

Entry Fee

10. There is an entry fee of £10 per rider. Entry forms must reach Colette Walker by 6th April 2009 with the entry fee enclosed. **Cheques made payable to 'Moat View Riding Club'**
